

Project Overview:

Objectives:

This includes but is not limited to, rebuild boundary walls, corridors, rooms, stairs, roof, washrooms, storage rooms, hall area, and additional constructions such as kitchen, clinic, vocational training center, guard room, RO plant, and playground. Additionally, the project aims to procure and install necessary furniture, utilities, appliances, and materials to meet the building's requirements.

3. Scope of Work:

The scope of work encompasses comprehensive renovation activities as follows:

- Reconstructing of boundary wall: Building and renovating side and front boundary walls
- Corridor Renovation: Building and renovation of corridors.
- Room Renovations: Renovation of all 15 rooms.
- Windows and Doors Installation: Installation of windows and doors with frames in all rooms.
- **Renovation of stairs:** Renovation of stairs with proper structure.
- **Roof build:** Build a proper roof.
- **Renovation of washrooms:** Complete renovation of all 6 washrooms.
- Renovation of Storage Rooms: Renovation of storerooms.
- **Renovation of Hall Area:** Renovation of the hall area.
- Additional Constructions: Construction of a kitchen, clinic, VTC (Vocational Training Center), guard room, RO plant, and playground.
- **Furniture Requirements:** Procurement and installation of furniture for student and office use.
- **Renovation of Water Tank:** Comprehensive renovation of the existing water tank.
- Installation of Water Supply Lines: Procurement and installation of water supply lines to ensure adequate water distribution.
